Dear Congressman Newhouse:

Yakima Valley Conference of Governments (YVCOG) strongly supports Yakima County's **East-West Corridor Project** *Community Project Funding Program* submission for consideration as a funding candidate within the Transportation, Housing, & Urban Development Community Project Funding Request appropriation process.

The East-West Corridor Project is a 6-phase, Yakima/City of Yakima/Washington Department of Transportation (WSDOT) effort that will create a new urban arterial crossing Interstate 82 and the Yakima River connecting the City of Yakima to the urbanized unincorporated county area of Terrace Heights. This project alleviates congestion through Yakima's Central Business district (providing positive air quality benefits) and State Route 12 (reducing peak hour traffic volumes).

YVCOG is the federally-designated Metropolitan Planning Organization (MPO) and the state-designated Regional Transportation Planning Organization (RTPO) for the Yakima Valley region. One of YVCOG's primary duties is to develop a long-range transportation plan for the Yakima Valley region.

Yakima County's proposal is consistent with and implements the goals and policies of the *Yakima Valley Metropolitan* and Regional Transportation Plan 2020-2045 (M/RTP). The project aligns well with the M/RTP priorities of Safety, Preservation, Economic Vitality, Freight Mobility, Transit Enhancement, and Transportation Demand Management.

YVCOG welcomes the opportunity for promoting and assisting with stakeholder outreach activities related to this project. The **East-West Corridor Project** embodies our region's developing sustainable and livable community principals.
